AN ORDINANCE NAMING THE NEWLY OPENED ROAD ALONG THE A.P. TENDERO SPORTS ARENA AS A.P. TENDERO DRIVE IN THE MUNICIPALITY OF TIGBAUAN, ILOILO

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF TIGBAUAN IN SESSION ASSEMBLED:**

**SECTION 1. SHORT TITLE** – This ordinance shall be known as A.P. TENDERO DRIVE ORDINANCE.

**SECTION 2. COVERAGE** – This ordinance shall apply to the newly opened Road-Right-of-Way along the A. P. Tendencia Sports Arena.

**SECTION 3. OBJECTIVES:**

3.1. To comply with one of the provisions in the Memorandum of Understanding (MOU)

executed between the LGU Tigbauan and the Tendero Family on the opening of road-right-of-way connecting Barangay Tan Pael to the national Highway that said road be named after their late patriarch Andres Porras Tendero.

3.2. To memorialize into the consciousness of the people that indeed generosity and other good deeds are acknowledged in this municipality.


**SECTION 4. Separability Clause.** Should any section or provision of this Ordinance be declared void and ineffective by final judgment of a competent judicial authority, the other articles or provisions hereof, not affected thereby, shall continue to be in full force and effect.

**SECTION 5. Repealing Clause.** Any ordinance, resolution, executive order or local laws inconsistent herewith shall be deemed repealed, amended or modified accordingly.

**SECTION 6. Effectivity Clause.** This ordinance shall take effect 10 days after mandatory posting in at least three (3) conspicuous places in the municipality.
