AN ORDINANCE FOR THE RETITLING OF THE POSITION TITLE (PARENTHETICAL TITLE) OF THE MGDH I (CHIEF ENVIRONMENTAL MANAGEMENT SPECIALIST), SG 24-1 TO MGDH I (MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES OFFICER), SG 24-1 IN THE PLANTILLA OF LGU PERSONNEL CY 2023 FROM THE ANNUAL BUDGET OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the Civil Service Commission (CSC) Qualification Standard (Revised 1997) states that this item, MGDH I (Chief Environmental Management Specialist), SG 24-1 pertains to National Government Sector only;

WHEREAS, also upon validation of the request for publication of vacant position, MGDH I (Chief Environmental Management Specialist), SG 24-1, the CSC Field Office 6 advised the Local Government Unit to amend such position to MGDH I (Municipal Environment and Natural Resources Officer), SG 24-1 for the reason stated above;

WHEREAS, the appointment of the Municipal Environment and Natural Resources Officer (MENRO) is one of the mandated positions under Republic Act No. 7160 otherwise known as Local Government Code of 1991;

WHEREAS, Appropriation Ordinance No. 2022-003, entitled: *“An Ordinance Enacting The Fiscal Year 2023 Annual Budget For General Fund And Special Education Fund Amounting To Two Hundred Twenty Five Million Pesos (P225,000,000.00) And Eight Million Five Hundred Thousand Pesos (P8,500,000.00) For The Special Account Of The Municipality Of Tigbauan, Province Of Iloilo”*, which was approved by the Sangguniang Bayan last September 1, 2022 created the position of MGDH 1, but used the position title, “Chief Environmental Management Specialist” following the recommendation in DBM Local Budget Circular No. 137, s. of 2021 dated July 13, 2021;

WHEREAS, the Municipal Government of Tigbauan intended to create the position of MGDH 1 for the Office of the Municipal Environment and Natural Resources as Municipal Environment and Natural Resources Officer (MENRO);

NOW, THEREFORE, BE IT ORDAINED by the Honorable Sangguniang Bayan, that:

SECTION 1. This ordinance shall be known as *“An Ordinance Retitling the Position Title (Parenthetical Title) of the MGDH I (Chief Environmental Management Specialist), SG 24-1 to MGDH I (Municipal Environment and Natural Resources Officer), SG 24-1 on the Plantilla of LGU Personnel CY 2023 in the Annual Budget of the Municipality of Tigbauan, Province of Iloilo”*.


SECTION 2. *Retitling of MGDH I (Chief Environmental Management Specialist), SG 24-1 to MGDH I (Municipal Environment and Natural Resources Officer), SG 24-1.* The Office of the MENRO shall be headed by MGDH 1 with a title – Municipal Environment and Natural Resources Officer.

SECTION 3. *Separability Clause.* All position titles, “Chief Environmental Management Specialist” mentioned in Appropriation Ordinance No. 2022-003 shall be changed to “Municipal Environment and Natural Resources Officer”. All other provisions of said ordinance shall remain valid and subsisting.


SECTION 5. EFFECTIVITY – This Ordinance shall take effect immediately.
