Municipal Ordinance No. 2023-023

AN ORDINANCE FOR THE TEMPORARY CLOSURE OF A PORTION OF ALLERA STREET (IN FRONT OF THE ST. JOHN OF SAHAGUN PARISH CHURCH) AND TEMPORARY CLASSIFICATION AS ONE-WAY STREET OF A PORTION OF TEJERO STREET (BACK OF THE TIGBAUAN MUNICIPAL BUILDING) ON DECEMBER 16-30, 2023, FROM 5:00 O’CLOCK P.M UNTIL 10:30 O’CLOCK P.M. IN LINE WITH THE PROGRAMS AND ACTIVITIES OF THE LOCAL GOVERNMENT UNIT OF TIGBAUAN IN CELEBRATION OF THE CHRISTMAS SEASON

WHEREAS, the Local Chief Executive in a letter dated November 22, 2023, requested this August Body thru Hon. Lugen T. Ortilano, Vice Mayor and Presiding Officer for the urgent passing of the aforementioned Municipal Ordinance;

WHEREAS, the Local Government Code of 1991 provides, among others, under Section 21 (a), and (c), to wit:

- “Closure of Roads – (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction xxx;
- (c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and water works projects, the duration of which shall be specified by the local chief executive concerned in a written order: xxx.”

NOW, THEREFORE, BE IT ORDAINED by the Honorable Sangguniang Bayan, that:

Section 1. **COVERAGE** – In line with the programs and activities of the Local Government Unit of Tigbauan in celebration of the Christmas Season, this municipality, the portions of aforementioned streets, namely: Allera Street shall be temporarily closed to motor vehicles and Tejero Street shall be temporarily classified as one-way street.

Section 2. **DURATION**– The temporary closure shall take effect, upon approval of this ordinance from 5:00 o'clock P.M. until 10:30 o'clock P.M. on December 16-30, 2023.

Section 3. **MISCELLANEOUS PROVISIONS** – The Punong Barangays of Poblacion 8 and Poblacion 9, Tigbauan, Iloilo, with the aid of their Barangay Tanods and the Tigbauan PNP shall facilitate the implementation of this ordinance and shall maintain safety health protocols, peace and order of the area for the entire duration of the temporary closure.

Section 4. **SEPARABILITY CLAUSE** – If any provision of this ordinance shall be declared null and void, unconstitutional or in conflict with the existing laws, ordinances and decrees, other parts not affected thereby shall remain valid and enforceable.

Section 5. **EFFECTIVITY** – This Ordinance shall take effect on December 16-30, 2023.


