Municipal Ordinance No. 2023-025

**AN ORDINANCE AMENDING SECTIONS 10 AND 11 OF MUNICIPAL ORDINANCE NO. 2001-003-
"AN ORDINANCE FOR THE COLLECTION AND DISPOSAL OF SOLID WASTES/GARBAGE IN THE
MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO AND PROVIDING PENALTIES THEREOF"**

SECTION 1. SHORT TITLE - This ordinance shall be known as "**GARBAGE COLLECTION ORDINANCE**".

SECTION 2. COVERAGE - This ordinance shall apply to the whole Municipality of Tigbauan, Iloilo.

SECTION 3. OBJECTIVES:

3.1. To amend certain provisions of Municipal Ordinance No. 2001-003, particularly, Section 10. Collection and Transportation of Solid Wastes/Garbage; and Section 11. Disposal of Solid Waste or Garbage.

3.2. To properly implement the Ecological Solid Waste Management System of the Municipality of Tigbauan, for the segregation at source, segregated transportation, storage, transfer,

processing, treatment, and disposal of solid waste and all other waste management activities which do not harm the environment.

3.3. To fix the schedule of daily collection of residual wastes in all the barangays of Municipality of Tigbauan.

SECTION 4. AMENDING SECTION 10. COLLECTION AND TRANSPORTATION OF SOLID WASTES.

a) Segregation at source: All solid wastes shall be segregated at source, on the following manner, to wit:

1. BIODEGRADABLES

- Food Wastes
- Kitchen Refuse
- Fruit Peels
- Vegetables Wastes
- Pet Droppings
- Fish Bones
- Leaves
- Grass
- Egg Shells
- etc.

2. RECYCLABLES

- Papers and Boxes
- Bottles
- Tin Cans
- Steel Bars
- Scrap Metals
- Disposable Spoon/Fork/Cup/Plate
- Plastic Bottles
- Aluminum Cans
- etc.

3. RESIDUALS

- Plastic/Sando Bags
- Candy/Biscuit wrappers
- Styrofoam
- Laminated Packaging (Tetra Packs/Doy Packs)
- Shampoo/Toothpaste Sachet
- Sanitary Napkins, Diapers
- Broken Ceramics
- Cigarette Butts

4. SPECIAL WASTES- (refer to household hazardous wastes)

- Paints
- Thinners
- Household Batteries
- Lead-acid Batteries
- Spray Canisters
- Bulky Wastes such as:
 - Large Worn-out or Broken Furniture
 - Lamps
 - Bookcases
 - Filing Cabinets
- Consumer Electronics such as Radio, Stereo, TV sets
- White Goods such as Stoves, Refrigerators, Dishwashers, Clothes Washers, Dryers, Oil, Tires

- b) Solid wastes from the plaza and the market area shall be collected daily, from **8 a.m. to 5 p.m.** to be brought to the central Material Recovery Facility (MRF) for processing;
- c) Recyclable wastes from households and other establishments shall be collected daily and deposited at the Barangay MRF;

- d) Collection of Residual wastes shall be done every **Tuesday and Friday**, from **8 a.m. to 5 p.m.**, but shall only be brought out of their respective household/establishment upon the arrival of the garbage collectors.

SECTION 5. AMENDING SECTION 11.DISPOSAL OF SOLID WASTES.

- a) Biodegradable Wastes shall be used as composting materials. Vegetable wastes in households shall be placed in compost pits, pots, or sacks. Vegetable wastes from the Tigbauan Public Market shall be placed in sacks and delivered to the composting facilities.
- b) Recyclable wastes shall be sold to junk shops or be brought to the barangay Material Recovery Facilities. Wastes delivered to the Barangay Material Recovery Facilities, shall be the responsibility of the barangay for disposal to junkshops.
- c) Residual wastes shall be safely kept at the Residual Containment Facility until transferred to the sanitary landfill.
- d) Special wastes shall be properly handled and stored at the Special Waste Containment Facility before final disposal. High Temperature Thermal Decomposition may be used to detoxify and ultimately destroy hazardous wastes.

SECTION 6. SEPARABILITY CLAUSE. If any part of this Ordinance is declared unconstitutional or unlawful, such declaration shall not affect the other parts or sections hereof that shall not be declared unlawful or unconstitutional.

SECTION 7.REPEALING CLAUSE. All previous ordinances inconsistent with this Ordinance shall be deemed repealed or modified accordingly.

SECTION 8.EFFECTIVITY. This ordinance shall take effect 10days after mandatory posting in at least three (3) conspicuous places in the municipality.
