AN ORDINANCE INSTITUTIONALIZING THE “TIGBAW MANGIBABAW AWARDS” FOR OUTSTANDING TIGBAUANONS AND EXEMPLARY PERFORMANCE IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO”

Section 1. Short Title - This ordinance shall also be known as “AN ORDINANCE INSTITUTIONALIZING THE “TIGBAW MANGIBABAW AWARDS FOR OUTSTANDING TIGBAUANONS AND EXEMPLARY PERFORMANCE” OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO” or “TIGBAW MANGIBABAW” Ordinance for short.

Section 2. Declaration of Policy - Section 16 of the Local Government Code entitled “General Welfare” states that:

“Every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.”

Section 3. In order to promote community involvement towards the achievement of this, the Local Government Unit of Tigbauan renews its commitment to empower its citizens by recognizing efforts

of bonafide Tigbauanons who in one way or the other contribute to the said goal, and whose acts bring pride and honor to the Municipality of Tigbauan, Province of Iloilo.

Section 4. Scope - The Tigbaw Mangibabaw Awards for Outstanding Tigbauanons and Exemplary Performance is hereby institutionalized. It shall be a search and an award for Tigbauanons who excel in their respective fields of expertise and who bring pride and honor to the Municipality of Tigbauan.

Section 5. Definition of Terms:

- a. **“Tigbauanon”** - For the purpose of this ordinance, the term “Tigbauanon” shall refer to a person who is a registered voter and a resident of Tigbauan during the time of the application for the award or is related to a person who qualifies to be a Tigbauanon based on the preceding qualification until the sixth (6th) degree of consanguinity;
- b. **Exemplary Performance** - performs all core job duties at an extraordinary level and demonstrates consistent mastery in all aspects of duties and responsibilities. Accepts a high level of responsibility for their own performance and routinely demonstrates an exceptional commitment to service;
- c. **Incentives** - is a powerful tool to influence certain desired behaviors or action often adopted by governments and businesses.
- d. **Portfolio** - is a compilation of academic work, accomplishments, and other evidence used to evaluate student or individual learning growth and academic.
- e. **Awardee** - the recipient of an award or special honor.

Section 6. Grant of Awards - There shall be two different categories granted for qualified Tigbauanons in the Tigbaw Mangibabaw Awards:

- 1. Tigbaw Mangibabaw Awards for Outstanding Tigbauanons; and
- 2. Tigbaw Mangibabaw Awards for Exemplary Performance.

Section 7. Tigbaw Mangibabaw Awards for Outstanding Tigbauanons - This award shall be given to those who can accumulate the highest points based on their qualification and portfolio screened and validated from the pool of nominees. Regardless of the number of nominees, there must only be one Tigbauanon conferred with this award for a specific field which are:

- 1. Public Service/Governance
- 2. Environment
- 3. Economic
- 4. Social
 - 4.1 Culture and Arts
 - 4.2 Sports

Section 8. An awardee may only be given a recognition under one field per year. Other fields may be left vacant if no one qualifies to receive the Outstanding Award.

Section 9. The Local Chief Executive, with a screening committee created through an executive order, shall create the guidelines, criteria, and point system to be used during the search. They shall be the body responsible to decide and approve additional fields if necessary. Provided that the total number of awardees shall not exceed ten (10).

Section 10. These awards shall be conferred to their qualified recipients every January in celebration of the Annual Tigbauan Devotional Fiesta.

Section 11. Tigbaw Mangibabaw Awards for Exemplary Performance - This award no longer needs to be approved and screened by the screening committee mentioned in the preceding section. Recipients of this award may be nominated by the different existing councils and offices in the Local Government Unit of Tigbauan and different national agencies and offices present in the Municipality of Tigbauan. Provided that they exhibit exemplary performances that bring pride and honor to Tigbauan in their respective fields in the Congressional, Provincial, Regional, National, or International Level.

It shall be the Local Chief Executive who has the discretion to confer this award anytime the need to award an individual or group arises.

Section 12. Awards - Awardees shall receive the following incentives, subject to the availability of funds, and a plaque:

For Tigbaw Mangibabaw Awards for Outstanding Tigbauanons - Ten Thousand Pesos
(P10,000.00)

For Tigbaw Mangibabaw Awards for Exemplary Performance - Depending on the level of their
achievements:

- Top 1 - One Thousand Five Hundred Pesos (P1,500.00)
- Top 2 - One Thousand Pesos (P1,000.00)
- Top 3 - Five Hundred Pesos (P500.00)

Provincial

- Top 1 - Three Thousand Pesos (P3,000.00)
- Top 2 - Two Thousand Pesos (P2,000.00)
- Top 3 - One Thousand Pesos (P1,000.00)

Regional

- Top 1 - Five Thousand Pesos (P5,000.00)
- Top 2 - Three Thousand Pesos (P3,000.00)

- Participant - One Thousand Pesos (P1,000.00)

National

- Top 1 - Ten Thousand Pesos (P10,000.00)

Section 13. Appropriation - Initial funding necessary to carry out the provisions and purposes of this ordinance shall be appropriated from any available sources in the General Fund of the municipality, subject to the existing laws, rules, and issuances, and shall be included in the subsequent annual budget of the Municipality of Tigbauan.

Section 14. Repealing Clause - Any ordinance, rule or regulation, or executive order which may be inconsistent herewith is hereby amended or repealed accordingly.

Section 15. Separability Clause - If for any reason, any part of provision of this Ordinance shall be held or declared to be invalid, other parts or provisions hereof which are not affected thereby shall continue to be in effect.

Section 16. Effectivity - This Ordinance shall take effect after complying with the requirements as to mandatory posting as provided for under Section 59 of RA 7160.
