AN ORDINANCE TEMPORARILY AMENDING MUNICIPAL ORDINANCE NO. 2022-005 OR ALSO KNOWN AS THE SALUDAN FESTIVAL ORDINANCE OF 2022 TO CELEBRATE THE SALUDAN FESTIVAL 2024 ON OCTOBER 11-19, 2024

BE IT ORDAINED BY THE SANGGUNIANG BAYAN THAT:

SECTION 1. Section 5 of the Municipal Ordinance No. 2022-005 entitled, ORDINANCE INSTITUTIONALIZING “SALUDAN FESTIVAL” OF THE MUNICIPALITY OF TIGBAUAN ON THE FOURTH WEEK OF OCTOBER OF EVERY YEAR AND PROVIDING FUNDS THEREFORE AND FOR OTHER PURPOSES” shall be temporary amended as follows:

SCHEDULE AND DURATION OF THE FESTIVAL - Saludan Festival shall be observed on **October 11-19, 2024**. It shall commence on Friday of the 2nd week of October and ends on Saturday of the third week thereof, as a celebration of the bountiful harvest of the Tigbauanons.

SECTION 2. VALIDITY. This ordinance shall only be valid for the Fiscal Year 2024.


SECTION 3. REPEALING CLAUSE. Any ordinance, rule or regulation, or executive order which may be inconsistent herewith is hereby amended or repealed accordingly.

SECTION 4. SEPARABILITY CLAUSE. If for any reason, any part of provision of this Ordinance shall be held or declared to be invalid, other parts or provisions hereof which are not affected thereby shall continue to be in effect.

SECTION 5. EFFECTIVITY. This Ordinance shall take effect on the day following its approval and publication, upon compliance with the requirements of the Local Government Code.
