Municipal Ordinance No. 2024-028

AN ORDINANCE AUTHORIZING THE TEMPORARY CLOSURE OF THE PORTION OF TEJERO STREET AND ALLERA STREET, BARANGAY 9 POBLACION ON OCTOBER 10-22, 2024 FROM 3:00 O’CLOCK IN THE AFTERNOON TO 3:00 O’CLOCK IN THE MORNING OF THE FOLLOWING DAY IN CONNECTION WITH THE HOLDING OF THE SALUDAN 2024 FOOD FESTIVAL

WHEREAS, the Local Government Code of 1991 provides, among others, under Section 21 (a), and (c), to wit:
“Closure of Roads – (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction xxx;
(c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and water works projects, the duration of which shall be specified by the local chief executive concerned in a written order: xxx

WHEREAS, through Municipal Ordinance No. 2022-005, the Municipality of Tigbauan shall celebrate Saludan Festival every October;

WHEREAS, one of the highlights of the said celebration is the holding of “Food Festival” in this municipality;

WHEREAS, the LGU has identified the following portions of roads/streets within the poblacion as the sites for the holding of “Food Festival” in this municipality:

- A portion of Allera Street specifically in front of the old Tigbauan Police station.
- A portion of the Tejero St., specifically at the back of the Tigbauan Municipal Building passing to the side of Tigbauan Public Market going to Brgy. 9 (Pob.)/Sta. Lucia;

WHEREAS, the *Food Festival* activities start at 3:00 o'clock in the afternoon up to 3:00 o'clock in the morning;

NOW, THEREFORE, BE IT ORDAINED by the Honorable Sangguniang Bayan, that:

Section 1. COVERAGE – In connection with the celebration of Saludan Festival, the portions of Allera and Tejero Streets, Poblacion of this municipality, shall be temporarily closed to motor vehicles;

Section 2. DURATION– The temporary closure shall take effect upon approval of this ordinance, from October 10-22, 2024 starting 3:00 o'clock in the afternoon up to 3:00 o'clock in the morning;

Section 3. MISCELLANEOUS PROVISIONS – The Traffic Management Coordination Committee Office (TTMCC), Punong Barangay of Poblacion 9, Tigbauan, Iloilo with the aid of their Barangay Tanods and the Tigbauan PNP shall facilitate the implementation of this ordinance and shall maintain the peace and order of the area for the entire duration of this temporary closure.

Section 4. SEPARABILITY CLAUSE – If any provision of this ordinance shall be declared null and void, unconstitutional or in conflict with the existing laws, ordinances and decrees, other parts not affected thereby shall remain valid and enforceable.

Section 5. EFFECTIVITY – This Ordinance shall take effect on October 10-22, 2024, 2020.
