Resolution No. 1, S. 1991

RESOLUTION REQUESTING FROM THE DEPARTMENT OF AGRICULTURE FOR A PUMP-  
BOAT TO BE USED IN THE PATROL OF MUNICIPAL WATERS.

WHEREAS, Tigbauan being a coastal town gets its main revenue from  
fishery rentals of fishery zones more specifically of fish corral  
sites;

WHEREAS, the SB has noted that the fishery revenue of Municipality the recent years have continued to decrease because fish corral sites have become unattractive to bidders;

WHEREAS, the reason why this is so is the frequent encroachment of trawlers and motorized "hulbed" operators of the 200-mt. distance from the stationary fish pens;

WHEREAS, it is also observed that some transient fishermen from other Municipalities e.g. "hulbed-hulbed" go to the extent of using dragnets which destroy the fish sanctuaries which if left unchecked will surely deplete the fishery resources of the Municipality;

WHEREAS, in view of these reasons there is an urgent need for the Municipality to patrol its Municipal Waters;

WHEREAS, the police officers are not in a position to conduct the needed patrol because the Municipality cannot afford to buy a speedy motorized pumpboat to apprehend said fishery violators;

WHEREAS, the ASTIGMA, an association of small fishermen in this Municipality has been extended funds by the Department of Agriculture to purchase a pumpboat for their livelihood and the Municipality cannot use said pumpboat for patrol purposes;


NOW, THEREFORE, on motion of Honorable Wilfrede Terania, Chairman on Agriculture and Fisheries and unanimously seconded,

RESOLVE, to request from the Department of Agriculture for a pump-boat to be used in the Patrol of Municipal Waters,

RESOLVED FURTHER, to forward copies of this resolution to Director Emigdio Tabella, Regional Director, Department of Agriculture, Region VI, Iligan City, for their information and appropriate action.
