RESOLUTION AUTHORIZING THE DEPOSIT IN THE BANK OF THE TOWNFIESTA FUNDS
WITH THE MUNICIPAL MAYOR, MUNICIPAL TREASURER AND SANGGUNIANG BAYAN
MEMBER WILFREDO TERANIA AS SIGNATORIES.

WHEREAS, the Townfiesta Steering Committee this year has agreed
that whatever funds that maybe derived from the activities during the
1991 Townfiesta shall be used to finance the expenses in preparation
of the 1991 SISA Meet which the Municipality will host;

WHEREAS, the net amount of ₱55,970.80 was realized from the
Beauty Contest, Coronation Ball and Canteen excluding the funds from
the Souvenir Program.

WHEREAS, for safekeeping, the Committee unanimously agreed that
this amount be deposited with Tigbauan Rural Bank, so that the
amount will be expended wisely for the proposed infrastructure
projects that are needed for the 1991 SISA Meet;

WHEREAS, the Municipal Officials hereby designate the Municipal
Mayor, Municipal Treasurer and Sangguniang Bayan Member Wilfredo
Terania as signatories to said deposit;

RESOLVE, to authorize the deposit in the bank of the Townfiesta
