labor yet an inferior quality of workmanship;


NOW, THEREFORE, on motion of Honorable Gerrylin Santuyo, Chairman

in preparation for 1991 SISA Meet to be hosted by the Municipality,


RESOLVED FURTHER, to forward a copy of this resolution to
