RESOLUTION REQUESTING FROM THE US AGENCY FOR INTERNATIONAL DEVELOP-
MENT (USAID) THRU THE DIRECTOR, PUBLIC INVESTMENT STAFF, NATIONAL
ECONOMIC AND DEVELOPMENT AUTHORITY (NEDA), NEDA BUILDING AMBER
AVENUE, PASIG, METRO MANILA, TWO (2) DUMP TRUCKS, ONE (1) GRADER,
ONE (1) PAYLOADER, ONE (1) FIRETRUCK, ONE (1) SERVICE JEEP AND
OFFICE EQUIPMENTS LIKE TYPEWRITERS AND FILING CABINETS.

WHEREAS, Tigbauan, an agricultural Municipality in the
Province of Iloilo is a fifth class Municipality depending on
real property tax for its main revenue;

WHEREAS, there is then an urgent need to maintain the up-
keep of its farm to market roads, interlinking barangay roads
and all possible road networks so that farm produce could reach
the public market and booster market revenue;

WHEREAS, heavy equipments like dumptrucks, graders and pay-
loaders will be very useful in the various development projects
in the Municipality;

WHEREAS, services of allied heavy equipment from the
Provincial Engineer's Office or the Department of Public Works
and Highways (DPWH) cannot be easily availed by the Municipality
when urgently needed because said truck team are also needed in
various public work projects in the other Municipalities or sites;

WHEREAS, the Municipality of Tigbauan cannot afford to
purchase said heavy equipment nor a firetruck which will come
handy in cases of fire occurrences;

WHEREAS, the Municipality also needs more office equipments
like typewriters and filing cabinets for a more speedy delivery
of public services;


NOW, THEREFORE, on motion of Honorable Andres Triste and unanimously seconded,

RESOLVE, to request from the US Agency for International Development (USAID) Thru the Director, Public Investment Staff, National Economic and Development Authority (NEDA), NEDA Building Amber Avenue, Pasig, Metro Manila, Two (2) Dump Trucks, One (1) Grader, One (1) Payloader, One (1) Firetruck, One (1) Service Jeep and Office Equipments like typewriters and Filing Cabinets,


