RESOLUTION CONDOLING THE BEREAVED FAMILY, FOR THE SUDDEN DEATH OF MR. JOAQUIN TURAO, EMPLOYEE OF THIS MUNICIPALITY.

WHEREAS, on June 1, 1992 at around 11:00 A.M. our departed brother succumb to cardio respiratory arrest and was finally beckoned by His Creator at 6:25 in the evening of the same day after hoping and clinging to dear life for around 6 hours at Iloilo St. Paul's Hospital;

WHEREAS, our departed 44 year old brother was born on December 4, 1948, the 6th son of the 7 children of the late Ignacio Turao and Dolores Tobias;

WHEREAS, he finished his elementary and High School Education at the Tigbauan Elementary School and Tigbauan National High School respectively;

WHEREAS, at the age of 21 years, he met the 17 year old Sheba Tuvilla, entered marital life and was blessed with 5 children, namely:

2. Marichu Turao..... 18 years old
3. Arthur Turao..... 16 years old
4. Rigel Turao..... 12 years old
5. Richel Turao..... 12 years old

WHEREAS, he is a father who has been so concerned and dedicated to the welfare of his family, so much so that he overlooked and took for granted his state of health in his endeavor to uplift the economic condition of his family;

WHEREAS, he was a very responsible and thoughtful father, has dearly cared and loved his family, that, quite unknown to many of us at the time of his cardiac arrest, he was at a restaurant making orders for a take home pasalubong;

WHEREAS, the untimely death of Joaquin was so traumatic and brought unmeasured sorrows to his family and loved ones;

WHEREAS, Joaquin as he was fondly called by his colleagues, friends and co-workers started working on August 1, 1986 as a casual employee in the Municipal Government of Tigbauan and became a utility worker in the same office from July 1, 1989 until his sudden death on June 1, 1992;

WHEREAS, he was an amiable and a friendly fellow that he gave life and happiness to his co-workers and friends;

WHEREAS, as a municipal employee who was assigned at the public market, the deceased has consistently demonstrated a high sense of responsibility and conducted his duties conscientiously and with utmost dedication;

WHEREAS, the Municipal Government of Tigbauan would like to express its sincere and heartfelt condolence to the bereaved family,

NOW, THEREFORE, on motion of Honorable Remedios Torrato and was unanimously seconded,

RESOLVE, as it is hereby resolved to condole and convey its deepest sympathy to the bereaved family for the sudden death of Mr. Joaquin Turao, employee of this Municipality,
