

Resolution No. 44-B, S. 1992

RESOLUTION APPROPRIATING THE AMOUNT OF P6,000.00 FOR EXPENSES TO BE INCURRED IN THE PLACING OF NAMEPLATES CONTAINING THE NAMES OF THE OFFICIALS WHO WERE INSTRUMENTAL IN THE EXPANSION OF THE LEFT-WING OF THE MUNICIPAL HALL, THE EXPANSION OF THE PUBLIC MARKET, THE CONSTRUCTION OF THE MULTI-PURPOSE CENTER, AND THE CONSTRUCTION OF THE TIGBAUAN NATIONAL HIGH SCHOOL GRANDSTAND, CHARGEABLE AGAINST THE FUND ALLOTTED FOR THE OTHER SERVICES OF THE SANGGUNIANG BAYAN.
