

Resolution No. 60, S. 1992

RESOLUTION CALLING ON ALL COMMUNITY-BASED PEOPLE ORGANIZATIONS OR NON-GOVERNMENTAL ORGANIZATIONS (NGO'S) INCLUDING BUSINESS AND PROFESSIONAL AND OTHER SIMILAR AGGRUPATIONS TO APPLY FOR ACCREDITATION FOR MEMBERSHIP IN THE LOCAL SPECIAL BODIES AND INFORMING THEM OF THE PROCEDURES AND GUIDELINES THEREOF UNDER ARTICLE 64, RULE XIII OF THE RULES AND REGULATIONS IMPLEMENTING THE 1991 LOCAL GOVERNMENT CODE.

WHEREAS, the 1991 Local Government Code mandates for the participation of private sector as active partners in the pursuit of the local autonomy;

- (a) Local Development Council – one-fourth ( $\frac{1}{4}$ ) of the total membership of the fully organized council (i.e., representatives from the private sector);
- (b) Local Prequalification, Bids and Awards Committee (PBAC) – two (2) representatives of people's organization or NGO's represented in the LDC concerned, and a practicing Certified Public Accountant (CPA) from private sector, to be designated by the Local chapter of the Philippine Institute of Certified Public Accountant (PICPA);
- (c) Local Health – one representative from NGO's of the private sector involved in the health services in the municipality of Tigbauan; Province of Iloilo;
- (d) Local School Board – the duly elected president of the municipal federation of parent-teachers association (PTA), the duly elected representative of the teachers' associations in the municipality of Tigbauan, and the duly elected representative of the non-academic personnel of the public schools in the municipality of Tigbauan;
- (e) Local Peace and Order Council – One representative from the Veterans group in the Municipality of Tigbauan and at least three (3) representatives of the private sector coming from either the academic, civic, religious, youth, labor, legal, business and media organizations;
- (f) People's Law Enforcement Board (PLEB) – three (3) members who shall be chosen by the peace and order council from among the respected members of the community known for their probity and integrity, one (1) of whom must be a member of the Integrated Bar of the Philippines, Municipal Chapter/ Iloilo Chapter;

WHEREAS, under Rule XIII, Article 64 of the Rules and Regulations Implementing the 1991 Local Government Code, it is provided that within thirty (30) days from the organization of the newly elected sanggunian, the sanggunian shall call all community-based people's organization of NGO's including business and professional groups, and other similar aggrupations to apply with the Municipal Government of Tigbauan, through the Sangguniang Bayan, for accreditation for membership in the local special bodies;

WHEREAS, it may be possible that the private sector does not know the procedure and guidelines for selection of representatives of people's organizations, NGO's or the private sector;

NOW, THEREFORE, on motion of Honorable Jessie Terre, seconded by Hon. Rene Ledesma,
