

Resolution No. 96, S. 1992

RESOLUTION REQUESTING ALL OFFICIALS AND EMPLOYEES OF THE SOUTHEAST ASIAN FISHERIES DEVELOPMENT CENTER (SEAFDEC), AND OTHER PUBLIC OR PRIVATE ESTABLISHMENTS LIKE ILECO-I, INC., BANKS, PRAWN FRY OPERATORS, TRANSPORTATION OPERATORS, ALL RESIDENTS AND NON-RESIDENTS WORKING/EMPLOYING WITHIN THE TERRITORIAL JURISDICTION OF THIS MUNICIPALITY, RESIDENTS AND NON-RESIDENTS ALIEN, RESIDENTS AND NON RESIDENTS, FOREIGN CORPORATIONS OR BUSINESS/ OR THE FIDUCIARY TO FILE THEIR INCOME TAX RETURNS IN THE LOCAL BUREAU OF INTERNAL REVENUE OFFICE OR LOCAL COLLECTION AGENTS IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO AS REQUIRED BY THE NATIONAL INTERNAL REVENUE CODE OF THE PHILIPPINES.

WHEREAS, under Section 284 of the Local Government Code of 1991, 30% for 1992, 35% for 1993, and 40% for 1994 for the collection of Internal Revenue in the form Internal Revenue Allotment (IRA) shall accrue to the municipality where the tax is paid;

WHEREAS, it is necessary to campaign for an increase in the collection of taxes by the BIR in the Municipality of Tigbauan, Province of Iloilo;

WHEREAS, an increase in BIR Collection in the Municipality of Tigbauan would mean an increase of an IRA Allotment necessary to fund/ finance various projects in this municipality;

WHEREAS, ON MOTION of Honorable J. Terre, Chairman Committee on Appropriation and duly seconded by Hon. R. Ledesma,

WHEREFORE PREMISES CONSIDERED, RESOLVED AS IT IS HEREBY RESOLVED, to request all Official and Employees of SEAFDEC and other Public or Private Establishments like ILECO-I, Inc., Bank, Prawn Fry Operators, Transportation Operators, all Residents and Non-Residents working/ employing within the territorial jurisdiction of this municipality, residents and non-residents Alien, residents and non-residents foreign corporations or business/ or the fiduciary to file their Income Tax Returns in the Local BIR or Local Collection Agents in the Municipality of Tigbauan, Province of Iloilo as required by the National Internal Revenue Code of the Philippines.

RESOLVED FURTHER, to forward copies of this resolution to Chief of SEAFDEC, ILECO I, INC., Municipal Treasurer, BIR Tigbauan Collection Agent, the Media and all concerned for their information and proper dissemination.
