

Resolution No. 103, S. 1992

RESOLUTION GRANTING MAYOR CELSO T. LEDESMA A BLANKET AUTHORITY TO MAKE THE NECESSARY NEGOTIATIONS WITH THE LOCAL GOVERNMENT INFRASTRUCTURE FUND PROJECT MANAGEMENT OFFICE (LGIF-PMO) AND TO REQUEST MR. APOLO C. JUCABAN, PROJECT DIRECTOR, LGIF-PMO, 4TH FLOOR, CLMC BUILDING 259-269 E. DELOS SANTOS AVENUE, GREENHILLS, MANDALUYONG, METRO MANILA, OR ANY OF HIS REPRESENTATIVE TO VISIT THE MUNICIPALITY OF TIGBAUAN FOR THE BRIEFING OF THE LOCAL OFFICIALS ON THE PROPOSED IMPROVEMENT OF THE PUBLIC MARKET, THE CONSTRUCTION OF SOME SCHOOL BUILDINGS AND THE CEMENTING OF SOME BARANGAY ROADS.

WHEREAS, as per information by the Municipal Mayor, Honorable Celso T. Ledesma, this Body had come to know the programme that is being undertaken by the LGIF-PMO, a USAID assisted project, of which the DPWH is the lead agency;

WHEREAS, cognizant of the need to improve the public market to put up additional school buildings and to improve barangay roads this body was unanimous in giving the Mayor a blanket authority to make the necessary negotiations and to support his plans to tap the resources of LGIF-PMO;

NOW, THEREFORE, on motion of Honorable Rene Ledesma and duly seconded by Honorable Ma. Bernardita Taasan,

RESOLVE, AS IT IS HEREBY RESOLVED, to grant Mayor Celso T. Ledesma A Blanket Authority to make the necessary negotiations with the Local Government Infrastructure Fund-Project Management Officer (LGIF-PMO) and to Request Mr. Apolo C. Jucaban, Project Director LGIF-PMO, 4th floor, CLMC Building, 259-269 E. de los Santos Avenue Greenhills, Mandaluyong, Metro Manila or any of his Representative to visit the Municipality of Tigbauan for the briefing of the Local Officials on the proposed improvement of the public market, the construction of some School Buildings and the Cementing of some Barangay Roads,

RESOLVED FURTHER, to forward copies of this resolution to Mr. Apdo C. Jucaban, Project Director, LGIF-PMO 4th Floor, CLMC Building, 259-269 E, de los Santos Avenue Greenhills, Mandaluyong, Metro Manila and to Honorable Celso T. Ledesma, Municipal Mayor, this Municipality, for their information and favorable action.
