

Resolution No. 156, S. 1992

RESOLUTION REQUESTING THE PROVINCIAL GOVERNMENT THROUGH THE PROVINCIAL GOVERNOR TO PROVIDE VINCIAL CAPITOL FOR THE FEDERATION OF THE SANGGUNIANG BAYAN MEMBVERS OF ILOILO AND TO PROVIDE ADEQUATE STAFF TO MAN THE SAME WHICH OFFICE SHALL ALSO SERVE AS THE OFFICE OF THE FEDERATION'S PRESIDENT WHO IS AN EX-OFFICIO MEMBER OF THE SANGGUNIANG PANLALAWIGAN OF ILOILO.

WHEREAS, the organization of federation of elective local officials is encouraged and has been institutionalized under the provisions of Title VI of the Local Government Code of 1991;

WHEREAS, in line with said objectives, DILG Memorandum Circular No. 92-81, dated October 26, 1992, was issued to effect the reorganization of the Federation of the Sangguniang Bayan Members in all the province in the Philippines, including Iloilo, which reorganized and elected their new set of officers last November 17, 1992;

WHEREAS, in accordance with the provisions of Section 467 (a) and 508 (b) of the Local Government Code of 1991, the duly elected Presidentof the Federation of the Sangguniang Bayan Members of Iloilo has already taken his oath of office and has assumed the office as an ex-officio of the Sangguniang Panlalawigan of Iloilo;

WHEREAS, we, the members of the said Federation, are expected through the instrumentality of our organization to become conscious of our role to be effective partners of our people and the government in the pursuit of national development and social progress;

WHEREAS, our Provincial Federation President is likewise expected by law, the people of the Province of Iloilo and more particularly all the Municipal Councilors, to perform his functions and duties as Member of the Sangguniang Panlalawigan of Iloilo;

WHEREAS, concomitant to these said expectations, we deem it most essential that our Provincial Federation President and our organization which he represents be provided by the Provincial Government of Iloilo with the same facilities and staff similarly enjoyed by the other members of the Sangguniang Panlalawigan of Iloilo;

NOW, THEREFORE, be it resolved by the Sangguniang Bayan of Tigbauan, Iloilo, to request the Provincial Government of Iloilo through the Provincial Governor and the Sangguniang Panlalawigan to allocate and assign a separate suitable office at the Provincial Capitol for the Federation of the Sangguniang Bayan Members of Iloilo and to provide adequate staff to man the same which office shall serve also as the office of the President who is an ex-officio Member of the Sangguniang Panlalawigan of Iloilo,

RESOLVED, FURTHER, that a copy of this resolution be furnished to Governor Arthur D. Defensor, Office of the Sangguniang Panlalawigan and Vice-Governor Robert Maroma.
