RESOLUTION AUTHORIZING THE MUNICIPAL TREASURER TO RELEASE THE AMOUNT OF FIVE THOUSAND (P5,000.00) PESOS FOR THE EXPENSES TO BE INCURRED IN CONNECTION WITH THE NATIONAL IMMUNIZATION DAY, CHARGEABLE AGAINST THE APPROPRIATION ON HEALTH FROM THE 20% IRA.

WHEREAS, the Department of Health (DOH), in coordination with the LCU's, NGO's and PO's have organized the ceasefire for children movement with the commitment to prioritize the health and welfare of children for national development;

WHEREAS, in view hereof, an activity through National Immunization Day (NID) will be held on April 21, and May 19, 1993;

WHEREAS, expenses will be incurred during such activity on April 21, 1993;

NOW, THEREFORE, on motion of Honorable Ma. Bernardita Taasan and duly seconded by Honorable Remedios Torrato,

RESOLVE, to authorize the Municipal Treasurer to release the amount of Five Thousand (P5,000.00) Pesos for the expenses to be incurred in connection with the National Immunization Day chargeable against the appropriation on health from the 20% IRA,
