RESOLUTION REQUESTING THE SANGGUNIANG PANTALAWIGAN TO ADOPT/CONCUR WITH RESOLUTION NO. 93 - 055, OF THE SANGGUNIANG BAYAN, TIGBAUAN, ILOILO.

WHEREAS, Sangguniang Bayan's Resolution No. 93 - 055 (as attached herewith) provides for the Body's (S.B.'s) concurrence with Barangay Baguingin's Resolution No. 10, S. 1993 this Municipality requesting the Secretary of the Department of Agriculture to cancel/reject fishpond application No. 38339 and No. 38763 of Mr. Nelson Jamandre and Mr. Antonio Galante respectively, to the 25,084 square meters public land located thereat, and to subdivide the same among landless residents of said barangay;

WHEREAS, as a condition precedent to grant Barangay Baguingin's request, the Secretary of DA thru the DENR requires that Sangguniang Bayan's Resolution No. 93 - 055 be adopted by the Sangguniang Pantalawigan;

NOW, THEREFORE, on motion of Honorable Jose Edgar Gaton and duly seconded by Honorable Ma. Bernardita T. Tassan,
