RESOLUTION NO. 93-082

RESOLUTION AMENDING SANGGUNIANG BAYAN'S RESOLUTION NO. 93-052 TO INCLUDE THE POSITION OF TWO (2) ADDITIONAL MIDWIVES, EFFECTIVE JULY 1, 1993.

WHEREAS, this body in its session dated May 3, 1993, had unanimously approved Resolution No. 93-052 - Resolution Creating in the Municipality's 1993 Organizational Structure and Staffing Pattern, the Department of Health (DOH) Devolved Positions, and confirming the appointments of the personnel for each position;

WHEREAS, only seven (7) positions for midwives were created in the abovementioned resolution;

WHEREAS, considering the population of the municipality, seven (7) midwives are not enough to deliver adequate services to fifty two (52) barangays, hence there is a need to create additional positions for midwives;

NOW, THEREFORE, on motion of Honorable Ma. Bernardita Taasan, Chairman Committee on Health and duly seconded by Honorable Remedios Torrato,

RESOLVED, to amend Sangguniang Bayan's Resolution No. 93-052 to include the position of Two (2) Additional Midwives, effective July 1, 1993
