Transportation & Public Utilities,

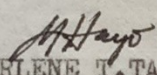
RESOLVE, AS IT IS HEREBY RESOLVED, to earnestly request the

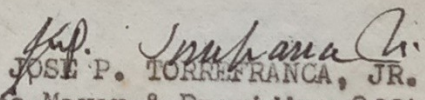

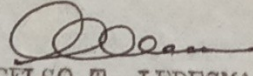

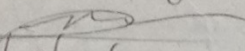
