Resolution No. 93 - 111

RESOLUTION CONCURRING WITH THE PROPOSED DISTRICTING OF PRECINCTS FOR DISTRICT I AND II OF THE MUNICIPALITY OF TIGBAUAN, ILOILO.

WHEREAS, pursuant to Comelec Resolution No. 93 - 2442 promulgated on September 24, 1993 on districting of municipalities into two (2) districts, in relation to Republic Act No. 7166, for the purpose of the subsequent local elections;

WHEREAS, the basis of districting provided by Law, amongst others, is based on the population of the local government units as of 1990 census and with the registered voters to be considered likewise;

WHEREAS, Mrs. Badiola, Election Officer III of this Municipality, has proposed the districting of the Municipality into two (2) districts with District I comprising of twenty one (21) barangays with 12,309 registered voters and District II comprising thirty one (31) barangays with 10,740 registered voters;

WHEREAS, this division into two (2) districts has been found to be feasible and has complied with the requirements mandated under Comelec Resolution No. 93 - 2342;

NOW, THEREFORE, it is unanimously approved, as it is hereby resolved, to concur with the proposed districting of precincts for District I and District II of the Municipality of Tigbauan, Iloilo,

RESOLVED FURTHER, to forward copies of this resolution to Mrs. Herminia D. Badiola, Election Officer III of this Municipality, the Sangguniang Panlalawigan, the Department of Interior and Local Government (DILG) and the COMELEC Regional Office, for their information and appropriate action.
