RESOLUTION AUTHORIZING THE MUNICIPAL TREASURER TO RELEASE THE AMOUNT
OF FIVE THOUSAND (P5,000.00) PESOS AS PAYMENT OF CONVENTION, TRAVEL,
AND OTHER RELATED EXPENSES OF HONORABLE DANTE GLARINO, ABC PRESIDENT
IN ATTENDING THE FIRST LIGA NG MGA BARANGAY NATIONAL CONGRESS CHAR-
GEABLE AGAINST THE TRAVELLING EXPENSES OF THE OFFICE OF THE SANGGU-
NIANG BAYAN FOR FISCAL YEAR 1994.

WHEREAS, the Liga ng mga Barangay is institutionalized under
the Local Government Code of 1991 for the primary purpose of deter-
mining the Liga representation in the Provincial, City and Municipal
Sanggunians;

WHEREAS, the Liga mandated to draft a uniform set of Constitution
and By-Laws applicable to the National Liga and all its Local chapters
which shall be ratified in a National Assembly called for this pur-
pose in accordance with Rule XXIX Article 210 of the Implementing Rules
and Regulations of the Code;

WHEREAS, pursuant to such objectives, the Liga ng mga Barangay
will be holding its 1st National Congress and General Assembly on
January 10-12, 1994 at the Philippine International Convention Center
(PICC) with the primary purpose of ratifying its Constitution and
By-Laws;

WHEREAS, in view of said scheduled activity and as mandated by
DILG Memo Circular #93-153 dated November 8, 1993, the Municipal
Mayor, Presiding Officer and members of the Sangguniang Bayan are
directed to extend the necessary assistance to the municipal ABC
President;

Atty. Gen. J. Imparato Jr.


