RESOLUTION APPROVING THE ADJUSTMENT OF THE DAILY WAGE OF THE CASUAL EMPLOYEES/LABORERS. THIS MUNICIPALITY, FROM P63.00 TO P80.00 EFFECTIVE JULY 1, 1994 TO DECEMBER 31, 1994

WHEREAS, pursuant to Section 447 (1) (viii) of the Local Government Code of 1991, the Sangguniang Bayan shall determine the wages of the casual employees paid wholly or mainly from municipal funds;

WHEREAS, in order to alleviate the plight of the underprivileged employees of this municipality it is necessary that wages of the laborers shall be increased;

NOW, THEREFORE, on motion of Honorable Jessie Terre, duly seconded by Honorable Andres Triste and Honorable Remedios Torrato,

RESOLVED, to approve the adjustment of the daily wage of the Casual Employees/Laborers, this Municipality, from P63.00 to P80.00 effective July 1, 1994 to December 31, 1994,

RESOLVED FURTHER, to forward copies of this resolution to the Municipal Mayor, to the OIC of the Municipal Treasurer's Office, to the Municipal Accountant and to the Municipal Budget Officer, for their information and/or appropriate action.
