RESOLUTION INFORMING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS OF THE EXTENT OF
DAMAGE OF EROSION AT THE RIVER BANK OF BARANGAY PARARA NORTE, TIGBAUAN, ILOILO,
BROUGHT ABOUT BY TYPHOON “ELYANG” AND REQUESTING TECHNICAL INVESTIGATION AND
FINANCIAL ASSISTANCE FOR THE CONSTRUCTION OF THE RIVER BANK PROTECTION WALL

WHEREAS, due to the strong current of water brought about by heavy rains during typhoon
“Elyang” the river bank collapsed washing away approximately 2,002 square meters of land and thirty
seven (37) productive coconut trees;

WHEREAS, seven (7) houses near the river bank were relocated for fear of loss of lives and
properties of the affected barangay residents;

WHEREAS, the erosion brought inconvenience to the marginal fishermen in bringing their catch
to the market because the area that was damaged included the newly developed barangay road;

WHEREAS, massive accumulation of silt at the center of the river is one of the obstructions that
when heavy rains come and produce river floods, the water flows side by side of the river banks that
later cause the erosion or the collapse of the bank;

WHEREAS, erosion of the river banks affect the bridge abutments of the existing Parara Bridge,

WHEREAS, the only measure to avoid further damage and inconvenience of the populace is the
construction of the river bank protection wall;

WHEREAS, the municipality and the Barangay have no sufficient funds for the construction of
the River Bank Protection Wall;

NOW, THEREFORE, on motion of Honorable Ramon Ledesma, duly seconded by Honorable Jose
Edgar Gaton and Honorable Andres Triste, the body hereby

RESOLVED, to conform the Department of Public Works and Highways (DPWH) of the extent of
damage of erosion at the river bank of Barangay Parara Norte, Tigbauan, Iloilo brought about by
Typhoon “Elyang” and requesting technical investigation and financial assistance for the construction of
the river bank protection wall,

RESOLVED FURTHER, to furnish copies to the Office of the Provincial Governor, Honorable Arthur Defensor, Honorable Richard Garin, Provincial Board Member, Chairman Committee on Infrastructure and the Office of the Department of Interior and Local Government for their information and contributory actions.
