RESOLUTION REALIGNING THE AMOUNT OF TWENTY THOUSAND (P20,000.00) PESOS FROM THE ILOILO
PROVINCIAL SCHOOL BOARD INTENDED FOR TABLET CHAIRS OF BINALIUAN NATIONAL HIGH SCHOOL TO
MULTI-PURPOSE STAFF OF SAID SCHOOL

WHEREAS, the Binaliuan National High School received financial assistance from the Provincial
Board of Iloilo in the amount of P20,000.00 for the purchase of Tablet Chairs of the school;

WHEREAS, the tablet chairs are not the immediate need of the school since it has an adequate
number of chairs for its students;

WHEREAS, the School is holding its activities in an improvised stage which is not conducive for
formal programs, or graduation and a lot more;

WHEREAS, during inclement weather the school cannot go on with the program as scheduled;

WHEREAS, the present priority need of the School is the Multi-Purpose Stage for holding
programs and other school activities;

NOW, THEREFORE, on motion of Honorable Jessie Terre, duly seconded by Honorable Agaton
Tumabotabo,

RESOLVED, to realign the amount of P20,000.00 from the Iloilo Provincial School Board
intended for Tablet Chairs of Binaliuan National High School to Multi-Purpose Stage of said School,
