RESOLUTION INCREASING THE BASIC SALARY OF MUNICIPAL EMPLOYEES, THIS MUNICIPALITY, UNDER THE REVISED COMPENSATION SYSTEM IN THE LOCAL GOVERNMENT AND FULL IMPLEMENTATION OF THE RATA OF MUNICIPAL OFFICIALS IN COMPLIANCE WITH LOCAL BUDGET CIRCULAR NO. 55 DATED MARCH 15, 1994 EFFECTIVE FISCAL YEAR 1995

WHEREAS, this year 1994, the Sangguniang Bayan of Tigbauan approved the granting of 40% Salary Increase based on the implementing guidelines by the Department of Budget and Management under Memo Circular No. 54, S. 1994 dated March 9, 1994;

WHEREAS, the remaining 60% under said implementing guidelines shall be given to the Municipal Employees effective Fiscal Year 1995;

WHEREAS, the Municipal Officials shall be receiving effective Fiscal Year 1995 the full implementation of RATA based on Local Budget Circular No. 55 dated March 15, 1994 issued by the Department of Budget and Management;

NOW, THEREFORE, on motion of Honorable Jessie G. Terre and duly seconded by Hon. Agaton Tumabotabo,

RESOLVED, to increase the Basic Salary of Municipal Employees, this municipality, under the revised Compensation System in the Local Government and full implementation of RATA of the Municipal Officials in compliance with Local Budget Circular No. 55 dated March 15, 1994 effective Fiscal Year 1995,

RESOLVED FURTHER, to forward copies of this resolution to the Municipal Mayor, OIC Municipal Treasurer, Municipal Accountant and the Municipal Budget Officer, for their information and guidance.
