Resolution No. 1994-074

RESOLUTION EXEMPTING FROM 1994 OPEN THE LIM-AO AREA FRONTING BUYU-AN BRIDGE, THE PALUPADAN WHICH COVERS THE FISHING SITE FROM THE MARINE BOUNDARY OF THE MUNICIPALITY OF OTN AND TIGBAUAN TO THE MOUTH OF BAGUINGIN CREEK, AREAS 1,2 AND 3 AND THE "BANGUS" FRY AREA IN BARANGAY NO. 8 AND NO. 9 AND IMPOSING CASH PAYMENT FOR THE WHOLE YEAR

WHEREAS, Lim-ao site was awarded to Mr. P. Garibay in the amount of P90,000.00 per year for three (3) consecutive years starting from 1990 to 1993 repectively;

WHEREAS, the minimum annual rental for Palupadan of P50,000.00 with a cash deposit of P22,000.00 pursuant to the provision of the Revised Fishery Ordinance No. 93-001 but last year during the time of the bidding no interested concessioner participated for two (2) consecutive biddings thereby the municipality forced to award to a concessioner in the amount of P20,000.00;

WHEREAS, the "Bangus" fry area in Barangay No. 8 and No. 9 has a minimum annual rental of P7,000.00 each but there was no collection of taxes as of date;

WHEREAS, this year 1994 the offer for Lim-ao by an interested concessioner is P120,000.00, Palupadan is P30,000.00 and the "Bangus" Fry area in Barangay No. 8 and No. 9 is P40,000.00, all in full cash payment of P190,000.00 payable to the Municipal Treasurer after the grant of the exclusive Fishery privilege;

WHEREAS, despite of the efforts of the Municipal Government of Tigbauan, Iloilo to collect taxes/rental from fishing activities in its municipal waters in 1992 to 1994 there were still a lot of concessioners who failed to comply their obligation to pay in full of its balance and some have not yet even paid a single centavo;

WHEREAS, the Municipal Government of Tigbauan cannot allow this kind of transaction which will redound to the disadvantages of this and people in general;

NOW, THEREFORE, on motion of Honorable Jose Edgar Gaton, duly seconded by Honorable Rene Ledesma and Honorable Andres Triste,

RESOLVED, as this Sangguniang Bayan of Tigbauan, Iloilo hereby resolves, to exempt from 1994 open bidding the Lim-ao site fronting Buyuan bridge, the Palupadan which covers the Fishing Site from the marine boundary of the Municipality of Oton and Tigbauan to the Mouth of Baguingin Creek, Areas 1, 2 and 3 and the "Bangus" Fry are in Barangay No. 8 and Barangay No. 9 and imposing cash payment for the Whole Year,

RESOLVED FURTHER, to forward copies of this resolution to the Municipal Mayor, the O.I.C. of the Municipal Treasurer's Office, the Municipal Accountant and the Municipal Budget Officer, for their information and guidance.
