RESOLUTION APPROVING SUPPLEMENTAL BUDGET NO. 2 OF THE MUNICIPALITY FOR THE 40% SALARY INCREASE BASING ON THE FOURTH CLASS CATEGORY FOR THE PAYMENT OF THE 13<sup>TH</sup> MONTH SALARY/BONUS OF THE MUNICIPAL OFFICIALS AND EMPLOYEES, THIS MUNICIPALITY, AND AUTHORIZING THE OIC OF THE MUNICIPAL TREASURER/S OFFICE TO RELEASE THE AMOUNT OF THIRTY TWO THOUSAND SEVEN HUNDRED TWENTY ONE & 60/100 (P32,721.60) CHARGEABLE AGAINST THE BALANCE OF SUPPLEMENTAL BUDGET NO. 1 AND OVERESTIMATED 5% CALAMITY FUNDS AS OF 1994

WHEREAS, this year 1994, the computation of the 40% salary increase was intended only for the twelve (12) months' salary;

WHEREAS the supplemental budget in the amount of P32,000.00 representing the 40% salary differential shall be paid to cover the 13<sup>th</sup> month salary/bonus of the municipal officials and employees this year 1994;

WHEREAS, this amount shall be charged against the savings of the Balance of Supplemental Budget No. 1 and overestimated 5% calamity fund as of 1994 as certified by the Local Accountant and the OIC and the OIC of the Municipal Treasurer's Office;

NOW, THEREFORE, on motion of Honorable Jessie G. Terre, duly seconded by Honorable Ma. Bernardita Taasan,

RESOLVED, to approve the supplemental budget No. 2 of the municipality for the 40% salary increase basing on the fourth class category for the payment of the 13<sup>th</sup> month salary/bonus of the municipal officials and employees, this municipality, and authorizing the OIC of the Municipal Treasurer's Office to release the amount of Thirty Two Thousand Seven Hundred Twenty One & 60/100 (P32,721.60) chargeable against the balance of supplemental budget No. 1 and overestimated 5% calamity fund as of 1994;

RESOLVED FURTHER, to forward copies of this resolution to the Municipal Mayor, the OIC of the Municipal Treasurer’s Office, the Municipal Accountant and the Municipal Budget Officer for their information and appropriate action.
