RESOLUTION GIVING FULL AUTHORITY TO HONORABLE RENE LEDESMA TO FIND WAYS AND MEANS
THAT WILL SOLVE THE GARBAGE DISPOSAL PROBLEM OF THE MUNICIPALITY

WHEREAS, the Sangguniang Bayan received complaints from the residents of Barangay No. 1
and No. 2 regarding the dumping of garbage at the said barangays;

WHEREAS, garbage disposal had been the perennial problem of the municipality for the past
years;

WHEREAS, Honorable Rene Ledesma offered his services to find ways and means by looking for
a specific garbage disposal area and to ask the permission of the land owner to utilize the lot for that
purpose;

WHEREAS, it is also necessary that the dump truck of the municipality be detailed at the disposal
of Honorable Rene Ledesma for at least one (1) week for the surfacing and stockpiling of sand and
gravel at the proposed garbage disposal area;

NOW, THEREFORE, on motion of Honorable Ma. Bernardita Taasan and duly seconded by
Honorable Cornelia Teruel,

RESOLVED, to give full authority to Honorable Rene Ledesma to find ways and means that will
solve the garbage disposal problem of the municipality,

RESOLVED FUTHER, to forward a copy of this resolution to Honorable Rene Ledesma, for his
information and appropriate action.
