RESOLUTION REQUESTING HONORABLE GLORIA MACAPAGAL-ARROYO ASSISTANCE GROUP MISSION, THRU ITS PRESIDENT, MR. ALBERT DE LA SANTA, FOR FINANCIAL FOR WAITING SHEDS/STREET LIGHTS, ONE (1) UNIT AMBULANCE AND ONE (1) UNIT SERVICE VEHICLE (L-300) FOR THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the office of the Municipal Planning & Development Coordinator/Office of the Municipal Engineer sent/submitted various complied documents to the Honorable Gloria Macapagal-Arroyo Assistance Group Mission, thru its President, Mr. Albert de la Santa, for the development projects of the municipality;

WHEREAS, after receiving the said documents, Mr. de la Santa conducted personally the preliminary survey for this purpose and hinted that the assistance group mission is willing to extend financial assistance for the development projects of the town;

WHEREAS, the survey revealed that the Municipality of Tigbauan lacks waiting sheds/street lights for the welfare and well-being of its inhabitants;

WHEREAS, the Municipality of Tigbauan has no service vehicle for official use and an ambulance for bringing/rushing patients to the hospitals in case of emergency;

WHEREAS, transport facilities are badly needed in order to facilitate and effect transactions at the earliest possible time to meet the demands of the constituents;

WHEREAS, Tigbaueños had long been in dire need of said projects but the municipality’s IRA for development projects is not sufficient to finance the felt-needs of its populace;

NOW, THEREFORE, on motion of Honorable Rene Ledesma, duly seconded by Honorable Andres Triste and Honorable Cornelia Teruel,

RESOLVED, to request Honorable Gloria Macapagal-Arroyo Assistance Group Mission, thru its President, Mr. Albert de la Santa, for financial Assistance for waiting sheds/street lights, one (1) Unit Ambulance and One (1) Unit Service Vehicles (L-300) for the Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to forward copies of this resolution to Mr. Albert de la Santa, President, Senator Gloria Macapagal-Arroyo Assistance Group Mission, 3528-H Hilario Street, Corner Dayap, Palanan, Makati, Metro Manila, for his information and appropriate favorable action.
