RESOLUTION REQUESTING COL. EFREN S. QUINTOS, DISTRICT DIRECTOR, 1ST ILOILO DISTRICT  
COMMAND I, BARANGAY BAGUMBAYAN, TIGBAUAN, ILOILO, TO INTENSIFY THE CAMPAIGN AGAINST  
ILLEGAL GAMBLING “DAILY DOUBLE” IN THE MUNICIPALITY OF TIGBAUAN, AND APPREHEND THE  
VIOLATORS THEREOF

WHEREAS, “Daily Double” is a form of illegal gambling covered under RA 1602 and as such, it  
has the effect of causing poverty, dishonesty;

WHEREAS, its continued existence may lead to serious trouble in society such as crimes against  
persons and property, acts which are punishable by law;

WHEREAS, two weeks ago the First Mobile Force of the Iloilo Provincial Command apprehend  
four (4) persons in Barangay Barroc, Tigbauan, Iloilo, identified as “table managers” and two (2)  
“corridors” in Barangay Baguingin, Tigbauan, Iloilo engaging in said illegal activity;

WHEREAS, in line with the government’s all-out campaign against illegal gambling;

NOW, THEREFORE, on motion of Honorable Vice Mayor Jose P. Torrefranca, Jr., duly seconded  
by Honorable Ma. Bernardita Taasan,

RESOLVED, to request Col, Efren S. Quintos, District Director, 1st Iloilo district Command I,  
Barangay Bagumbayan, Tigbauan, Iloilo, to intensify the campaign against illegal gambling “Daily  
Double” in the Municipality of Tigbauan and to apprehend the violators thereof,

RESOLVED FURTHER, to forward copies of this resolution to Col. Efren S. Quintos, District  
Director, 1st Iloilo District Command I, Barangay Bagumbayan, Tigbauan, Iloilo, PNP-Tigbauan Police  
Station, thru Senior Inspector Bonifacio Servano, and the Municipal Mayor, for their information and  
appropriate favorable action.
