RESOLUTION AUTHORIZING MAYOR CELSO T. LEDESMA, THIS MUNICIPALITY TO DISBURSE THE AMOUNT OF FIFTEEN THOUSAND (P15,000.00) PESOS TO PAY THE DIRECT COST INCREASED ON THE DONATED AD-VAN- VEHICLE, CHARGEABLE AGAINST ANY AVAILABLE FUND

WHEREAS, pursuant to Resolution No. 94-004 dated January 18, 1994, the Sangguniang Bayan this municipality had authorized among others the disbursement of P50,000.00 to defray the transportation and other incidental cost of the AD-VAN Vehicle donated by the Government of Japan;

WHEREAS, in a letter dated August 23, 1994 by Mayor Jose T. Sison, Sr., National President of League of Municipalities of the Philippines (LMP), he Mayor this municipality was advised to prepare an additional amount of P15,000.00 per vehicle inorder to pay the direct cost increased incurred due to inevitable delay in transporting said vessel;

WHEREAS, as provided in aforesaid letter the needed additional amount will be released only as soon as the donated vehicle arrives;

NOW, THEREFORE, on motion of Honorable Andres Triste and duly seconded by Honorable Ramon Ledesma,

RESOLVED, to authorize Mayor Celso T. Ledesma, this municipality to disburse the amount of P15,000.00 to pay the direct cost increased on the donated AD-VAN Vehicle, chargeable against any available fund,

RESOLVED FURTHER, to furnish copies of this resolution to Honorable Celso T. Ledesma, Municipal Mayor and Mr. Gualberto B. Bernas IV, OIC Municipal Treasurer, for their information and appropriate action.
