RESOLUTION AUTHORIZING THE MUNICIPAL TREASURER TO RELEASE THE AMOUNT OF EIGHT THOUSAND FIVE HUNDRED PESOS & 32/100 (P8,530.23) TO PAY THE SALARY OF MRS. ELENA T. MONSERATE, ACTING S.B. SECRETARY FOR THE MONTH OF APRIL 4, TO MAY 7, 1994, CHARGEABLE AGAINST THE TEN THOUSAND (P10,000.00) PESOS REPRESENTATION EXPENSES OF THE OFFICE OF THE SANGGUNIANG BAYAN

WHEREAS, S.B. Secretary, Miss Marlene Tayo was on leave for a period of six months, starting April 4, 1994 to October 3, 1994 and was substituted by Mrs. Elena T. Monserate whose temporary appointment was approved by the Civil Service Commission;

WHEREAS, during the period of April 4 to May 7, 1994 Mrs. Elena T. Monserate has not yet receive her salary;

WHEREAS, in order to pay the services rendered by her it is incumbent upon the Municipal Government to revert the unexpended (P10,000.00) Representation Expenses of the Office of the Sangguniang Bayan,

NOW, THEREFORE, on motion of Honorable Rene Ledesma, and duly seconded by Honorable Remedios Torrato and Honorable Andres Triste,

RESOLVED, to authorize the Municipal Treasurer to release the amount of Eight Thousand Five Hundred Thirty Pesos & 32/100 (P8,530.32) to pay the salary of Mrs. Elena T. Monserate, Acting S.B. Secretary for the month of April 4 to May 7, 1994, Chargeable against the P10,000.00 Representation Expenses of the office of the Sangguniang Bayan,

RESOLVED FURTHER, to forward a copy of this resolution to Mr. Gualberto Bernas IV, OIC Treasurer for his appropriate action.
