RESOLUTION REQUESTING MR. MICHAEL SCKIRL, A GERMAN NATIONAL WHO IS PRESENTLY
OCCUPYING THE ABC MULTI-PURPOSE HALL AT BARANGAY NAMOCON, TIGBAUAN, ILOILO TO VACATE
THE HALL ON OR BEFORE DECEMBER 15, 1994

WHEREAS, Mr. Sckirl is presently occupying the Multi-Purpose Hall without any contract
whatsoever, hence the occupancy is illegal;

WHEREAS, during the recently completed barangay seminar conducted by the DILG many were
complaining about the management by Mr. Sckirl of the Multi-Purpose Hall;

WHEREAS, there were reports that the place is being used not in accordance with the principale
and moral values of the Tigbaueños;

NOW, THEREFORE, on motion of Honorable Rene Ledesma and duly seconded by Honorable
Andres Triste,

RESOLVED, to request Mr. Michael Sckirl, a German National who is presently occupying the ABC
Multi-Purpose Hall at Barangay Namocon, Tigbauan, Iloilo to vacate the Hall on or before December 15,
1994,

RESOLVED, FURTHER, to forward a copy of this resolution to Mayor Celso T. Ledesma for his
information and appropriate action,

RESOLVED FURTHER STILL, to forward a copy of this resolution to Mr. Michael Sckril for his strict
compliance,
