RESOLUTION APPROVING THE RELEASE OF FORTY SIX THOUSAND EIGHT HUNDRD SEVENTY TWO (P46,872.00) PESOS FOR THE HONORARIUM OF SIXTY SIX (66) BSPO'S AND ELEVEN (11) CATCHMENT PRESIDENTS OF BHW'S EFFECTIVE JANUARY 1994 CHARGEABLE AGAINST THE 20% IRA APPROPRIATION FOR NUTRITION, ENVIRONMENTAL SANITATION AND POPULATION DEVELOPMENT PROJECTS & AUTRHOZING THE OIC MUNICIPAL TREASURER TO RELEASE THE NEEDED AMOUNT THEREOF

WHEREAS, the Association of Barangay Service Point Officers of Tigbauan (BSPO's) and Association of Barangay Health Workers thru a letter dated December 8, 1994 of Mrs. Linda Fe T. Camiña, Population Program Officer I – Tigbauan, requested the Honorable Body for the approval of honorarium for 66 BSPOs and 11 catchment Presidents of BHWs effective January 1994 to December 1994 dsitributed as follows:

RESOLVED, to approve the Release of Forty Six Thousand Eight Hundred Seventy Two (48,872.00) Pesos for the Honorarium of 66 BSPO's and 11 Catchment Presidents of BHW's effective January 1994 chargeable against the 20% IRA appropriation for Nutrition, Environmental Sanitation and Population Development Projects and Authorizing the OIC Municipal Treasurer to release the needed amount thereof,

RESOLVED FURTHER, to forward copies of this resolution to OIC Municipal Treasurer for his appropriate action and to Mrs. Linda Fe T. Camiña for her information and guidance.
