RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HIS EXCELLENCY PRESIDENT FIDEL V. RAMOS FOR THE 50TH ANNIVERSARY CELEBRATION OF THE LIBERATION OF PANAY AND ROMBLON ON MARCH 18, 1945 AT TIGBAUAN, ILOILO

WHEREAS, Barangay parara which is one (1) kilometer away from the poblacion of the Municipality of Tigbauan is the historical site where the American Liberation Forces first landed on March 18, 1945 to liberate the islands of Panay and Romblon;

WHEREAS, this yearly celebration is always held with great significance and meaning, so much so that President Corazon C. Aquino in her Presidential Decree No. 430 dated July 21, 1989 had declared it to be a Victory Day and a special Non-Working Holiday in the whole Islands of Panay and Romblon;
