Resolution No. 95-010

RESOLUTION AMENDING RESOLUTION NO. 93-026 BY DETERMINING ALL LEVELS OF SECTORAL REPRESENTATION IN THE SANGGUNIANG, MUNICIPALITY OF TIGBAUAN, ILOILO, NAMELY: (1) WOMEN, (2) AGRICULTURAL & INDUSTRIAL WORKERS, (3) URBAN POOR INDIGENOUS CULTURAL MINORITIES, DISABLED PERSONS, PEASANTS/SMALL FARMERS/FISHERMEN, SENIOR CITIZENS AND WAR VETERANS

WHEREAS, this body in its February 22, 1993 session had approved Resolution No. 93-026, Resolution Determining The Sectors To Be Represented In The Second And Third Sectors Of The Sanggunian In The Municipality of Tigbauan, Iloilo namely: 1) Women, 2) Agricultural 3) Senior Citizen Sectors;

WHEREAS, COMELEC Resolution No. 2753, dated January 27, 1995 specifically Section 3, mandates to wit:

“Section 3. – election of Sectoral Representatives. – (a) In addition to the regular members of the Sangguniang Bayan, Sangguniang Panlungsod and Sangguniang panlalawigan mentioned in Sections 41 (c), 446,457 and 467 of the Local Government Code, there shall be three (3) sectoral representatives;

one (1) from the women, and, as shall be determined by the Sanggunian concerned within ninety (90) days prior to the holding of the local elections, one (1) from the agricultural or industrial workers, and one (1) from the other sectors to include but not limited to the urban poor, indigenous cultural minorities, disabled persons, peasants/small farmers/fishermen, senior citizens or war veterans.”

WHEREAS, in order to ensure compliances with the aforementioned provision of law, S.B. Resolution NO. 93-026 is hereby accordingly amended;

NOW, THEREFORE, on motion of Honorable Andres Triste and duly seconded by Hon. Remedios Torrato,

RESOLVED, to amend Resolution No. 93-026 by Determining all levels of Sectoral Representation in the Sanggunian, Municipality of Tigbauan, Iloilo, namely (1) Women, (2) Agricultural and Industrial Workers, (3) urban Poor, Indigenous Cultural Minorities, Disabled Persons, Peasants/Small Farmers/Fishermen, Senior Citizens and War Veterans,

RESOLVED FURTHER, to forward a copy of this resolution to Mrs. Herminia Badiola, Election Registrar, and Mrs. Prescilla Napila, MLGOO V, for their information and guidance.
