RESOLUTION URGING AND APPEALING TO THE MEMBERS OF SENATE AND HOUSE OF REPRESENTATIVES  
FOR THE IMMEDIATE REPEAL OF THE EXPANDED VALUE ADDED TAX (EVAT) LAW

WHEREAS, the Expanded Value Added Tax (EVAT) is a form of indirect taxation which will ultimately be shouldered by the consumers;

WHEREAS, the implementation of the Expanded Value Added Tax, without the necessary campaign for the purpose of informing the Filipino taxpayers, has caused confusion to the public;

WHEREAS, the confusion and the lack of knowledge by the taxpayers on the mechanisms of the Expanded Value Added Tax have resulted to the problematic implementation of the same;

WHEREAS, the implementation of RA 7716 will set back the economic progress of the country and will greatly affect and already suffering countrymen;

WHEREAS, the immediate implementation of the Expanded Value Added Tax is not only ill-timed due to the present economic problems facing the country, but also due to the lack of information given to the public;

NOW, THEREFORE, on motion of Honorable Jessie G. Terre, SB Chairman, on Committee on Trade, Commerce and Industry and duly seconded by Hon. Jose Edgar Gaton,

RESOLVED, to urge and appeal to the members of Senate and House of Representatives for the immediate repeal of the Expanded Value Added Tax (EVAT) Law;

RESOLVED FURTHER, to forward copies of this resolution to the Senate Manila and House of Representative Manila, for their immediate and appropriate action.
