RESOLUTION NAMING THE BARANGAY ROAD EXTENDING FROM THE NATIONAL HIGHWAY IN
BARANGAY NAMOCON TO THE PROVINCIAL ROAD IN BARANGAY BAGUMBAYAN AS DON JOSE ZULUETA
DRIVE

WHEREAS, for the convenience of the people traveling from barangay Namocon to Barangay Bagumbayan or vice-versa, the Municipal Government under Mayor Clso Ledemsa proposed a plan and set aside from its 1993 and 1994 IRA Fund to finance the construction of a Barangay road connecting the roads from Barangay Namocon and Barangay Bagumbayan;

WHEREEAS, from Barangay Namocon to Barangay Bagumbayan, the affected properties are owned by the Zulueta Estate;

WHEREAS, the affected portion of the Zulueta Estate for the construction of the road has a deed of donation from Mr. Tony Z. Zayco, administrator and heir of Mrs. Maria Zulueta Zayco;

WHEREAS, the late Maria Zulueta Zayco and the late clemete Zulueta are the only daughter and son, and heirs of Don Jose Zulueta the owner of the vast tract of land in the Municipality of Tigbauan and is called as the Zulueta Estate;

WHEREAS, the heirs of the Zulueta Estate have decided and informed the Municipal Mayor that they would like to have the honor in memory of their grandfather Don Jose Zulueta to name the barangay road as Don Jose Zulueta Drive;

NOW THEREFORE, on motion of Honorable Jose Edgar Gaton, Chairman, Committee on Housing and Land Utization and duly seconded by Honorable Romeo Ledesma and Honorable Jessie Terre,

RESOLVED, AS IT IS HEREBY RESOLVED, to name the Barangay Road extending from the National Highway in Barangay Namocon to the Provincial Road in barangay Bagumbayan as Don Jose Zulueta Drive,

RESOLVED FURTHER, to furnish copies of this resolution to the Municipal Mayor, Mr. Tony Zayco, the Provincial Governor and the Municipal Planning and Development Office.
