RESOLUTION AGREEING TO PURCHASE THE POTABLE WATER THAT WILL BE SUPPLIED TO OUR MUNICIPALITY BY THE BUTT INDUSTRIAL DEVELOPMENT CORPORATION (BIDC) WITH THE SOURCE AT BARANGAY DAJA, MAASIN, ILOILO

WHEREAS, the municipality of Tigbauan is in need of potable water and also water for commercial and industrial purposes for its future industrialization;

WHEREAS, the water supply of Butt Industrial Development Corporation (BIDC) could supply the Municipality with enough water at no construction cost to the municipality with source at Barangay Daja, Municipality of Maasin thru a high impounding resources;

WHEREAS, the project is a Build, Operate and Transfer (BOT) Scheme with the Funders in joint venture with Butt Industrial Development Corporation (BIDC);

WHEREAS, BIDC and its funders are requiring that the Municipalities would pass a resolution approved by the Mayor that they buy the water consumed by its users;
