RESOLUTION REQUESTING THE DEPARTMENT OF HEALTH, MANILA, THRU THE REGIONAL DIRECTOR, REGION VI, ILOILO CITY, FOR FINANCIAL ASSISTANCE TO AUGMENT THE IMPLEMENTATION OF SALARY STANDARDIZATION LAW OF 1994 AND 1995 IN THE AMOUNT OF TWO HUNDRED TWENTY THOUSAND EIGHT HUNDRED EIGHTY FOUR (P220,884.00) PESOS FOR THE TEN (10) DEVOLVED PERSONNEL OF HEALTH TO THE MUNICIPALITY OF TIGBAUAN

WHEREAS, Local Budget Circular No. 54 provides for the standardization of salary of the Civil Service Employees and Executive Order No. 164 provides for the increase in basic salaries of Civilian personnel, effective January 1, 1994 as follows:

- 1) Salary Grades 1 to 10 . . . . P 800.00
- 2) Salary Grades 11 upward . . . . P 700.00

WHEREAS, Local Budget Circular No. 56 and Executive Order No. 218 in conformity with the Salary Standardization Law of 1994 provides for P1,000.00 increase in salary of all employees for the fiscal year 1995 regardless of rank and grade;

WHEREAS, ten (10) personnel of Tigbauan Rural Health Unit were not able to avail fully of said salary standardization for the year 1994 - 1995 due to lack of funds;

WHEREAS, in order to augment the implementation of Salary Standardization Law of 1994, the Municipal Health Office, Tigbauan, Iloilo, thru the Sangguniang Bayan of Tigbauan, requests the DOH, Manila, thru the Regional Director, for financial assistance to implement said law;

NOW, THEREFORE, on motion of Honorable Nelly P. Tolosa, Chairman, Committee on Health and duly seconded by Honorable Romeo Ledesma, Honorable Cornelio Teruel and Honorable Jessie Ferre, be it

RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Tigbauan, Iloilo, to pass a resolution requesting the Department of Health, Manila,

thru the Regional Director, Region VI, Iloilo City, for financial assistance to augment the implementation of salary standardization law of 1994 and 1995 in the amount of P220,884.00 for the Ten (10) Devolved Personnel of health to the Municipality of Tigbauan,

RESOLVED FURTHER, to furnish copies of this resolution to DOH, Manila; Municipal Health Office, Tigbauan; Mayor's Office; Municipal Budget Office; Municipal Treasurer's Office; Municipal Accountant's Office; Human Resource Management Office and the Sangguniang Panlalawigan of Iloilo for their information and appropriate action.



