RESOLUTION SUPPORTING HOUSE BILL NO. 4874 WHICH SEEKS TO EMPOWER THE LOCAL CHIEF EXECUTIVE AND THE SANGGUNIANG BAYAN IN THE DISPOSITION OF THE CALAMITY FUND AS PROVIDED FOR IN SECTION 324 (d) OF R.A. 7160

WHEREAS, House Bill No. 4874 as proposed by Congressman Roilo Golez shall empower the Local Chief Executive and the Sanggunian concerned in the disposition of the calamity fund particularly in the appropriation for relief, rehabilitation, reconstruction and other works or services in connection with calamities which may occur during the budget year, including pre-disaster activities such as organization, training and providing essential equipment for the use of the disaster coordinating council and disaster management/response teams, conduct of community drills and other disaster mitigation and prevention activities;

WHEREAS, this provision shall do away with the requirement that the President first declares a state of calamity before the calamity fund is released;

WHEREAS, cognizant of the advantages and merits of House Bill No. 4874, the Sangguniang Bayan of the Municipality of Tigbauan strongly supports the speedy deliberation and approval of the said bill;

NOW, THEREFORE, upon motion by Honorable Marlon C. Torrento, and duly seconded by Honorable Nelly Tolosa,

RESOLVED, to support House Bill No. 4874 which seeks to empower the Local Chief Executive and the Sanggunian in the disposition of the calamity fund as provided for in Section 324 (d) of R.A. 7160,

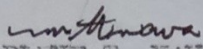

Tigbauan, Iloilo, for their information and guidance.

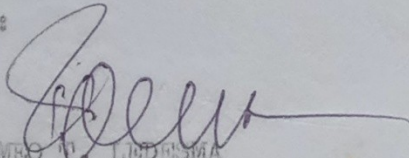

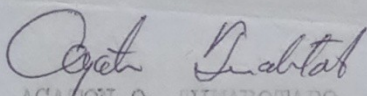
