RESOLUTION AUTHORIZING THE OIC MUNICIPAL TREASURER TO RELEASE THE AMOUNT OF TWENTY THOUSAND PESOS (P2,000.00) FROM THE CALAMITY FUND TO BE USED AS AID TO THE FIRE VICTIMS AT TUPAN STREET, BARANGAY 3, TIGBAUAN, ILOILO

WHEREAS, on or before 5:00 o'clock A.M., a fire of still undetermined origin broke out in one of the houses fronting the Tigbauan, National High School, Tupan Street, Barangay 3, Tigbauan, Iloilo;

WHEREAS, it was learned that four (4) houses were razed by the fire rendering four (4) families homeless:

WHEREAS, Section 447 (a) (iv) of the Local Government Code (R.A. 7160) substantially states that the Sangguniang Bayan shall: " provide relief services and assistance to victims during and in the aftermath of manmade or natural disasters and calamities"

WHEREAS, because of the miserable incident that happened to the fire victims and out of human compassion, the Sanggunian, as mandated by the provision of law above cited, is hereby authorizing the release of P20,000.00 for the families of the fire victims, itemized as follows:
