RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) THROUGH THE PROVINCIAL ENVIRONMENT AND NATURAL RESOURCES OFFICE, ILOILO CITY, AND THE MUNICIPALITY OF TIGBAUAN REPRESENTED BY THE MUNICIPAL MAYOR

WHEREAS, Congressman Mar Roxas, thru his initiative has appropriated an allocation of P45,000.00 for the Municipality of Tigbauan to cover funding requirements for plantation establishment;

WHEREAS, 10% of this allocation equivalent to P4,500.00 will be retained by the PENRO to cover administrative cost for its provincial /field personnel extending technical assistance for the duration of the project;

WHEREAS, the abovementioned financial assistance is badly needed for the greening program of this Municipality;

WHEREAS, the Municipality of Tigbauan will either provide or purchase the seedling in line with the plantation establishment and maintenance and protection activities;

WHEREAS, the release of the funds shall be in accordance with the approved work and financial plan;

WHEREAS, the Memorandum of agreement is a requirement by the DENR in order to avail of financial assistance for particular project;

NOWTHEREFORE, upon motion by Honorable Jessie G. terre, Chairman, Committee on Environmental Protection and duly seconded by Honorable Romeo Ledesma,

RESOLVED, AS WE HEREBY RESOLVE, to authorize the Municipal Mayor into a Memorandum of agreement (MOA) with the Department of Environment and Natural Resources (DENR) through the Provincial Environment and natural resources Office, Iloil City, and the Municipality of Tigbuana, represented by the Municipal Mayor,

RESOLVED FURTHER, to forward copies of this Resolution to the Department of Environment and Natural Resources (DENR) through the Provincial Environment and Natural Resources Office (PENRO), Iloilo City, for their information and/or appropriate action.
