RESOLUTION CREATING THE POSITIONS OF MUNICIPAL HEALTH OFFICER IN THE OFFICE OF THE MUNICIPAL HEALTH AND THE MUNICIPAL AGRICULTURIST IN THE MUNICIPAL AGRICULTURAL OFFICE, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO YEAR 1998

WHEREAS, Art. 24 of the implementing Rules and Regulations of the Local Government Code of 1991 mandates the transfer of power and authority from the National Government to the Local Government Unit to enable them to perform specific functions and responsibilities;

WHEREAS, the other National Government Agencies or Offices were also devolve to the Municipal Government of Tigbauan;

WHEREAS, this two specific head agencies, the Municipal Health Officer, and Municipal Agriculturist were not included in the devolution last 1992 when the Local Government Code of 1991 was already implemented;






