RESOLUTION TURNING OVER TO THE MUNICIPAL HEALTH OFFICE THE AMBULANCE GIVEN BY THE
PHILIPPINE CHARITY SWEEPSTAKES OFFICE

WHEREAS, the vehicle (ambulance) is necessary in line with the DOH attainment of the basic health services in the Municipality of Tigbauanas mandated in the Local Government Code of 1991, Article 25;

WHEREAS, the Local Government Code of 1991 Article 29 states that “. . . funding for the maintenance of this vehicle shall be taken from the LGU share of the national and other local revenues;

WHEREAS, there must be a designated driver to handle this vehicle who must be under the Municipal Health Office and will at the same time enjoy the benefits enjoyed by the Municipal Health Office and will at the same time enjoy the benefit enjoyed by the Municipal Health Office employee;

WHEREAS, it must be the duty of the LGU Tigbauan, to provide oxygen tank, medical kit and other paraphernalia needed in the ambulance, and at the same time, the fuel that will be used for his vehicle;

NOWTHEREFORE, on motion of Honorable Nelly Tolosa, Chairman, S.B. Committee on Health and Social services and duly seconded by Honorable Cornelia teruel and Honorable rene Ledesma ,

BE IT RESOLVED, to turn over to the Municipal Health Office the ambulance given by PCSO,

RESOLVED FURTHER, to forward copies of this Resolution to the Honorable Mayor Celso T. Ledesma and to the Municipal Health Officer, Dr. Alfredo Endonila for their information and guidance.
