NOW, THEREFORE, on motion of Honorable Nelly Tolosa, member, Committee on Budget, Finance and appropriation and duly seconded by Hon. Rene Ledesma,

RESOLVED, to concur with the Resolution of the Municipal Development Council, approving the allocation of the 1998 20% IRA Fund of the Municipality of Tigbauan in the amount of Three Million Nine Hundred Twenty Thousand Seven Hundred Ninety Eight Pesos & 60/100 (P3,920,798.60) to be used in the Different Development projects of trhe Municipality subject to the following conditions:

1. The Sangguniang Bayan should always be furnished by the Chief Executive clarificatory documents requested during its deliberation on the 20% Municipal IRA Fund in order not to delay concurrence of the same by the August Body.
2. There shall always b one (10 representative from the Samgguniang bayan (for the purpose of transparency) to sit as member of the committee on Awards (CA) during the bidding of projects (even if it is only for supply of materials0 since R>A 7160 never limits its membership.

- 3. Are bidding of the supply of materials for the improvement of the Plaza Stage shall be conducted since the previous bidding on the project cited above was done before the concurrence of the 20% Municipal iRA Fund,
- 4. During the presentation of every budget proposal like the 20% Municipal IRA Fund, the Chief Executive should allow the Departments Head/s concerned to enlighten the Sanggunian of any clarificatory questions that may arise pertinent thereto.
- 5. The Executive Department shall furnish copies to the office of the Sangguniang Bayan of any updated laws, memoranda, circulars, executive’s orders and the like from National agencies for earlier references.

RESOLVED FURTHER, to forward copies of this Resolution to the Office of Municipal Mayor, The Municipal Treasurer, the Municipal accountant, the Municipal planning and Development Coordinator, the Municipal Budget officer and the sangguniang Panlalawigan, for their information and guidance.
