RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE MYRNA M. TORRES AND THE MUNICIPAL ASSISTANT TREASURER, MRS. EDNA TUERES, TO BE THE SIGNATORIES OF CHECKS AND OTHER REQUIRED DOCUMENTS FOR THE DEPOSIT AND/OR WITHDRAWAL OR MUNICIPAL FUNDS FROM THE OFFICIAL DEPOSITORY BANKS OF THE MUNICIPAL GOVERNMENT OF TIGBAUAN, THE LAND BANK OF THE PHILIPPINES AND THE PHILIPPINE NATIONAL BANK, BOTH AT ILOILO CITY.

WHEREAS, the Municipality of Tigbauan, a 4th Class Municipality has chosen the Land Bank of the Philippines, and the Philippine national bank to be its Official depository banks and has opened an account therein;

WHEREAS, to insure a smooth flow of transactions/negotiations between the said banks and the Municipal Governments of Tigbauan, the Body has hereby authorized the Municipal Mayor and the Municipal assistant Treasurer to be the signatories of checks and other required documents for the deposit and/or withdrawal of the funds of the Municipal Government of Tigbauan;

NOW, THEREFORE, on motion of Honorable Ma. Bernadita Taasan and was unanimously seconded;

RESOLVED, as it is hereby resolve, to authorized the Municipal mayor, Honorable Mayor Myrna M. Torres and the Municipal Assistant Treasurer, Mrs. Edna Tueres to be the signatories of Checks and other required documents for the Deposit and/or Withdrawal of Municipal Funds from the Official depository banks of the Municipal Government of Tigbauan, the Land Bank of the Philippines and the Philippine National bank, both at Iloilo City.
