RESOLUTION ESTABLISHING A TEMPORARY EMERGENCY CLINIC FOR DENGUE FEVER VICTIMS AT THE MUNICIPAL HEALTH CENTER, TIGBAUAN, ILOILO

WHEREAS, per report receive by the municipality and as per information received by the Committee chairman on health and Sanitation, it was confirmed that all hospitals and clinics within the Province of Iloilo are now excess of dengue fever patients and cannot be accommodated anymore;

WHEREAS, it is lamentable to say that it is not only hospital accommodations that are lacking, but also medicines, laboratory equipments/materials including health personnel;

WHEREAS, in order to answer the needs of the people, it is imperative that this municipality shall establish a temporary emergency clinic to serve our dengue fever patients;

NOW, THEREFORE, on motion of Honorable Cecelia Garrido and duly seconded by Hon. Ma. Bernadita T. Taasan,

RESOLVED, AS IT IS HEREBY RESOLVED, to establish a temporary emergency clinic for dengue fever victims at the Municipal health Center, Tigbauan, Iloilo,

RESOLVED FURTHER, to forward copies of this Resolution to Hon. Arthur Defensor, Governor, Province of Iloilo, to Dr. Rodolfo Dumayas, Provincial Health Officer and Dr. Alfredo V. Eudonila, Municipal Health officer, for their information and guidance.
